## Highlights from the CCA board meetings held March 26 - 27, 2019 in Bermuda

### Welcome new board and corporate members

The Canadian Construction Association (CCA) welcomes 13 new board members from across Canada:

Gary Bale, Greg Clunie, Craig Drover, Steve Drummond, Jason Duke, Angela McKerlich, Scott Mugridge, Trevor Panas, Brad Piercey, Cory Richter, Frederick Vine, Terry Wilms and Julie Zulich.

We would also like to extend a warm welcome to new corporate members, [MKA Canada Inc.](#), based in Calgary, Alberta; and [Xana International Inc.](#), based in Concord, Ontario. The support of our corporate members is greatly appreciated as it enables us to be more effective in our advocacy efforts on behalf of the industry.

### Update on CCA priorities

#### Governance renewal project progressing well

The working group has already met twice since being tasked with renewing CCA's governance. They quickly realized that right-sizing the board is not the main challenge;

rather re-engaging those members and expanding the involvement of others is the bigger opportunity. The working group is being guided by three principles:

1. To re-focus the CCA board on strategic stewardship of CCA to help members in their continued success;
2. To strengthen opportunities for all members and partners to engage with CCA;
3. To improve the effectiveness of CCA in benefiting all members and partners. From small contractors to large suppliers, CCA is in service to the collective, and we need to provide opportunities that complement our members' capacity to participate.

The current thinking around board composition is as follows;

- Based on input from the November board meetings and best practices, board membership of between 15 to 20 individuals is likely.
- Nominations will be considered from individuals who fit the required profile (e.g. skills, experience and diversity factors).
- There is a gap in CCA's board in support of the monitoring function. With a smaller board, an executive committee would no longer be needed. Therefore, two new board committees should be created: Finance, Audit and Long-Range Planning Committee as well as Governance and Nominations Committee.
- More consideration around a member engagement strategy is required to build on CCA's existing and recently added opportunities, such as quarterly calls with partner association chief operating officers (COO) and the Hill Day.
- A meeting has been set up for April 14. The working group is considering other ideas, such as which of the remaining committees are operational and the potential for new co-hosted regional events on national issues.

### **2018 financials restored to surplus**

Due to careful management by CCA president and her staff, CCA ended the year in a surplus position of about \$198,000 compared to the budgeted deficit of \$298,530. The major reasons for this significant improvement are:

- Careful staff management leading to savings of \$136,500;
- Function cost savings from the conference of \$146,000;
- No significant unplanned expenses; and
- Successfully run seminars, Lean Construction Institute of Canada (LCI-C) conference and cost management of all committees/councils.

### **New, proactive initiatives to build CCA advocacy**

With 2019 being an election year, we will be building on the momentum from last fall's Hill Day. Our goal is to grow the number of members engaged in national issues of importance to the industry. With 20,000 member firms employing over 1.5 million Canadians, our united voice can make a difference.

Some of these new initiatives include:

- On November 26, CCA will celebrate national Construction Day. This initiative is in collaboration with our partner associations and is designed to raise the profile of the industry.
- Given the timing of the election, CCA will deliver through partner associations, a "Hill at Home" day. CCA will organize meetings with the COO and members in their home riding. CCA will also provide the key messages to be brought forward.
- An election website outlining CCA's position will be created, along with content and templated letters that can be pushed out from our members across Canada.
- To improve understanding of national issues and to share learnings, CCA will host COO calls on advocacy issues.

#### **CCDC 2 approval deferred**

CCA decided to defer the approval of the new Canadian Construction Documents Committee (CCDC) 2 'Stipulated Price Contract' in consideration of the feedback received from members on the new ready-for-takeover milestone, health and safety provisions as well as relocating CCDC 2 clauses to CCDC Master Specifications Division. A taskforce will be established to address these issues, and it will provide a recommendation at the May meetings.

#### **CCA strengthens its corporate member value**

The board approved a new and improved corporate member program initiative. This will include enhancing value for current corporate members and creating a new tier with unique value. Improving the value of corporate membership will strengthen our advocacy efforts, broaden our integrated membership and give CCA greater depth for national discussions.

#### **CCA to develop a training plan on the IPD process**

CCA recognizes the need for best practices and education on integrated project delivery (IPD) process and has tasked the CCA Standard Practices Committee to develop a plan.
