## Highlights

### **Liberty Utilities proposes \$9M pipeline in New Brunswick**

Liberty Utilities, formerly Enbridge Gas New Brunswick, is seeking approval for a new \$9 million natural gas pipeline in New Brunswick. The proposal marks the first major new energy infrastructure for the company since 2012.

Working in partnership with regional companies – Headwater Exploration, Maritimes and Northeast Pipeline and Graymont – Liberty is applying to the New Brunswick Energy and Utilities Board to construct and operate a pipeline serving the Havelock area in southern New Brunswick. [Read more](#)

### **U.S. Department of Energy awards Moltex Energy \$3.5 million**

Moltex Energy is being given \$3.5 million to advance its small modular reactor technology with its potential to provide low-cost, clean energy. Funds for Moltex to further develop its stable salt reactor-waste burner (SSR-W) technology are being awarded through an agency within the U.S. Department of Energy.

Moltex, a privately held nuclear power development company with headquarters in the UK and New Brunswick, has developed SSR-W to burn existing nuclear waste, reducing waste stockpiles while generating clean, grid-scale electricity.

### **Irving Oil reaches deal to buy refinery at Come By Chance, NL**

Irving Oil has signed agreements to buy the North Atlantic Refining Corp. and its Come By Chance refinery in Newfoundland and Labrador from New York-based investment firm, Silverpeak, for an undisclosed sum.

The agreements, subject to regulatory review and conditions of sale being met, also includes North Atlantic gas stations, Orange Stores and other marketing assets. The refinery, the only one in the province, has been shut down during the COVID-19 pandemic. It produces 135,000 barrels a day when operational. [Read more](#)

### **Saint John Energy to create 'utility of the future' for city**

Saint John Energy contributes \$100 million a year to the New Brunswick economy, according to a new report – an impact that could rise to an average of \$140 million annually over the coming decade.

Economist David Campbell evaluated the impact of the company's operations and forecasted what its growth strategy could mean for the economy, and presented his findings at the firm's first virtual annual general meeting.

The company says it is building the "utility of the future" for Saint John with its growth strategy, which includes an emphasis on innovating new products and services for customers and on renewable energy, including the Burchill Wind farm planned for the city. Another key project under the strategy is a smart grid for the city.

Herb Emery, columnist and Vaughan Chair of Regional Economics at the University of New Brunswick, has drawn a clear link between competitive energy rates and sustainable jobs in a recent blog post.

Emery looks at some of the key factors that explain why the province's manufacturing exports stalled during the past decade leading to stagnation of

the economy and the population. He focuses particularly on northeast New Brunswick which has not recovered from the loss of large industry – a big contributor to the province’s record for reducing emissions. [Read more](#)
